SCOPE OF WORK

The bidder is expected to **provide innovative network connectivity Infrastructure** and Services at PDCC Bank across the Pune District.

PDCC Bank have 300 Branches and 115 ATM across the Pune district. Which are connected with different connectivity. Branches have Primary BSNL wired/Wireless and Secondary are VPN, Reliance, and Broadband. In The Annexure 'A1' And 'A2' our current connectivity diagram/structure, used hardware/network component and Branch list are provided in RFQ.

In this respect following is expected from the bidder:

- Implementation of advance/latest technologies in network domain considering quality of services maximum uptime and availability, cost effectiveness from overall solution, maintenance & corresponding issues point of view.
- Maintenance of Network Infrastructure and Provide Services for 3 years contract term.
- 12x7x365 Support for network Infrastructure and Services.

Expected Network Setup

- a) **Reliable connectivity and guaranteed bandwidth with latest technology** for all locations of bank and Head Office.
- b) **Link connectivity** for ease of manageability and scalability.
- c) Easily scalable, flexible and cost effective.
- d) **Guaranteed SLA for uptime**, reliability and performance
- e) Class of Service implementation for its applications.
- f) Please refer Our Bank network Structure and Diagram in Annexure 'A1' And 'A2' for expected network setup and design

PROJECT DELIVERABLES

- a) The project will be executed from the PDCC Head Office and at all PDCC Bank locations mentioned in the RFQ.

IMPLEMENTATION

- a) Supply/Installation of hardware at PDCC Bank, network links / cabling.
 - b) Installation, commissioning, support and services for all the Branches.
 - c) The selected bidder(s) will be required to implement the network security measures in consultation with PDCC Bank during the Implementation phase.
 - d) The bidder will need to provide a detailed implementation plan including the architecture diagram, strategy, approach, and delivery of network, specific issues, and their resolutions.
 - e) Provide optimum performance, security, scalability and desired uptime requirements.

SERVICES AND SUPPORT

1. The Successful Bidder i.e. vendor should manage the entire network components involved in connectivity under this Network Architecture. Maintenance and management of last mile link/media and network equipment's will be the responsibility of the Vendor.
2. The Vendor will be responsible for managing all routers, switches and hardware/network components installed in PDCC Bank premises used for links connectivity.
3. The Vendor should carry sufficient inventories to assure ex-stock supply of consumables and spares. The Vendor shall ensure availability of spares in stock for immediate delivery.
4. The Vendor should have support center at Pune and having minimum 25 service engg at pune location.
5. The Vendor will plan, schedule, manage, and/or perform Install Move Add Change (IMAC) as requested and approved by the PDCC.
6. The Vendor should provide the configuration details to PDCC.
7. Maintenance of all the Hardware\Network equipment's (IT and Non IT) installed in PDCC premises should be done periodically by Vendor. A report of the same to be submitted to PDCC.
8. The Vendor has to provide Periodic MIS reports to PDCC.

PRODUCT AND SERVICES ACCEPTANCE

1. The acceptance testing will be carried out on commissioning of all the links.
2. All aspects of the network implementation will be tested as a part of the Acceptance Test which will include the delivery and installation of network hardware, provisioning of links, configuring of routers and other network equipment's, commissioning of links, connectivity testing, fault-tolerance and failover feature testing, end-to-end solution testing, and application access test. Details of the Acceptance Test to be carried out will be decided with the selected bidder during the Implementation phase.
3. The bidder needs to provide the appropriate test report as a part of Acceptance Testing.
4. Final Acceptance will be done only after successful commissioning of all the links.
